Mayor Pro-Tem Gorman moved to award contact to Fryer Construction Company for the Wastewater Treatment Plant Influent Bar Screen for the amount of \$188,000 and to authorize the Mayor to spend up to \$9,440 (5%) as a contingency if necessary for unforeseen field conditions. Town Engineer, Mike Anderson recommended to approve the bid award to Calvert Paving. Council Member Crider moved to award the bid to Calvert Paving. Motion seconded by Council Member Wilkinson. Mayor Pro-Tem Gorman made a secondary motion to award the contract to Calvert Paving Corporation of Denton, Texas on Petes Court reconstruction project in the amount of \$68,533.36 and to authorize the Mayor to spend up to \$3,426.67 and authorize project funds not to exceed \$4,067 for geotechnical testing and materials testing as necessary for a total project cost of \$76027.03.
