5. PUBLIC HEARING on a proposal to increase total tax revenues from properties on the tax roll in the preceding tax year by 5.12 percent.
6. Consider and act on approval of an Interlocal Agreement between the City of Krum and the Town of Ponder for EMS Services.
7. Consider and act on a zoning change request for: A0371a F. Davis, Tr 50, 12.37 acres, Old Dead Tr #10b. This 12.37 acre tract is located off of 400 Robinson Road directly behind the Denton County Cowboy Church. This tract is currently zoned SF2 and the Town of Ponder is recommending and requesting that a zoning change to AG. The surrounding properties to the north and west are zoned AG. The property owner is the Denton County Cowboy Church.
8. Consider and act on a request for a Specific Use Permit. This 12.37 acre tract is located and accessed off of 400 Robinson Road, directly behind the Denton County Cowboy Church. The property owner is requesting to build a multi use event center. The event center is considered to be part of the church and should be allowed under the Federal Religious Land Use and Institutionalized Persons Act, which was effective September 22, 2000.
