**ITEM 1 CALL TO ORDER**

Mayor Vardell called the regular session to order at 6:00 p.m. on Monday, November 23, 2009, in the Vivian Cockburn Municipal Building located at 405 Shaffner Street.

The ISD is in the process of getting a no drilling clause from Devon Energy and will close as soon as this has been done.

**ITEM 11 CONSIDER AND ACT ON APPROVAL OF A CONTRACT TO REPLACE THE SUPPORT BEAMS IN WELL #4 UTILIZING BOND FUNDS.**
